Empanelment of Project Management Consultants (PMC) to provide PMC Services under the Mega/ Integrated Food Park Scheme

The Andhra Pradesh Food Processing Society (APFPS), Industries Dept., Government of Andhra Pradesh is the nodal agency for implementing the Andhra Pradesh Food Processing Policy 2015-2020. APFPS is implementing Mega Food Parks Scheme (MFPS) and Integrated Food Parks Scheme (IFPS) under the Policy. APFPS invites applications from interested advisory/ consultancy firms for empanelment as Project Management Consultant (PMC) (in addition to the already empaneled agencies) for providing professional services to developers of Mega/ Integrated Food Parks as per the respective scheme guidelines

The prospective PMC should be an independent professional agency with multi-disciplinary skill set and should be positioned for providing professional expertise to SPVs in development of a Mega/ Integrated Food Park from Concept to Commissioning as per the guidelines of Mega/ Integrated Food Park Scheme of Andhra Pradesh Food Processing Society (APFPS), Government of Andhra Pradesh

The PMC will provide the following services to the developer of an approved Food Park

- a) Assist SPV in finalizing business plan and preparing detailed project report for the project as per guidelines of the scheme and requirements of bank and financial institutions providing term loan for the project.
- b) Plan and develop a techno commercially viable Mega/ Integrated Food Park with its CPC/ PPC & other components having an excellent potential to successfully support investments to be made by the Promoters of SPV through their own resources, bank debts & Government of Andhra Pradesh grants.
- c) Detailed engineering and design including preparation of detailed cost estimates for various project components/ facilities.
- d) Preparation of bid documents, selection and appointment of contractors/ equipment suppliers/ consultants, in a transparent manner, for project construction and supply of plant and machinery.
- e) Monitoring and overseeing the work output of the contractors/ equipment's suppliers/ consultants in compliance of the terms and conditions of the contracts/ appointments with the objective of ensuring quality, completeness and compatibility of the work carried out in relation to the Project.
- f) Prepare all necessary documentation for submission to APFPS in order to facilitate timely release of funds sanctioned under MFPS/ IFPS.
- g) Assistance to SPV in submission of monthly progress reports to APFPS in prescribed format.
- h) Ensuring efficient utilisation of funds to create good quality infrastructure assets without extra cost and time overruns

Agencies with the following credentials may apply before 21.01.2019 along with a non-refundable processing fee of Rs. 25,000/- by Demand Draft drawn in favour of 'AP Food Processing Society'

- Shall be an Institution, Consulting Firm/ Company with atleast three years' experience in providing advisory services to industrial park projects and should have specifically provided the range of PMC services to atleast 2 Nos. of industrial park projects each of project cost more than Rs. 50 crore, sanctioned by either Gol or GoAP. This should be supported by the work orders, client certificates, MoAs etc.
- Should have an annual turnover of more than Rs. 100 lakhs during any of the last three financial years and an average turnover of not less than Rs. 50 lakhs for the last three financial years. This should be supported by the audited annual reports and balance sheets for last three financial years.
- Should not have been blacklisted or debarred by any Central/ State Government Ministries Departments (an undertaking should be submitted on the letter head to this effect).

The application shall necessarily contain the following

- Duly signed application
- General team description along with CVs of team leader, experts and team members
- Documents in support of experience (work orders/ agreements/ client certificates etc)
- CA Certificate of the annual turnover and audited balance sheets for last three FYs
- Certificate of Incorporation, MoA, AoA, etc
